FYI I stopped by yesterday to check on construction status for these properties. Lot 11 (88 Cowpens) is still doing sitework – driveway not yet in. Lots 9 and 10 have "sold" signs out front and are pretty much complete with landscaping – a bit of site stabilization on 2185 Cobblehill is still ongoing.

However, the planters got built as in-ground planters not flow-through planters per the current O&M details, and some placement adjustments have been made. They will need to update the O&M again.



These O&Ms definitely comply with the shared maintenance of the bioretention planter/outfall (see screenshot below of the site map/responsibility).

However, the stormwater treatment O&Ms typically don't have anything to do with maintenance for a standard driveway (e.g., non-permeable). I'm not quite sure how we would incorporate that into this doc – because we wouldn't want to take inspection/reporting responsibility for it... Please make sure Agreements comply with this:

52. The applicant shall record documents which address future maintenance responsibilities of any private drainage, stormwater treatment or other common facilities which may be constructed. For example, documents would address maintenance of all shared access easements (i.e., Lots 5 through 8, and Lots 9 and 1 0), as well as shared maintenance of the bio-retention planter on Lot 8 (for the benefit of Lots 7 and 8) and the storm drainage outfall on Lot 9 (for the benefit of Lots 9 and 1 0). Prior to recording these documents, they shall be submitted to the Department of Public Works for review and prior to the issuance of a Certificate of Occupancy for the applicable parcel (Lots 5 through 10).

Hi Nikki –

Circling back around on this one. These draft O&M Agreements look good. Just a couple of (very minor) comments below.

In addition, do you know what the status of construction/photos is? It IS possible to record the documents without photos (you would have to remove the reference to the Exhibit and make the Annual Report form Exhibit D), but we will want to be VERY sure that the final storm drain system that is built is accurately reflected in the site plan. If the as-built conditions don't match the site plan then we would need to re-record, which is why we typically ask for photos/wait for completion before recording. However, if time is tight I did want to make it an option.
