Parking in Spaces for the Disabled

22507.8. (a) It is unlawful for any person to park or leave standing any vehicle in a stall or space designated for disabled persons and disabled veterans pursuant to Section.

22511.7 or 22511.8,

unless the vehicle displays either a special identification license plate issued pursuant to Section 5007 or a distinguishing placard issued pursuant to parked in the stall or space.

Fire Hydrants

<u>22514</u>. No person shall stop, park, or leave standing any vehicle within <u>15 feet</u> of a fire hydrant except as follows:

- (a) If the vehicle is attended by a licensed driver who is seated in the front seat and who can immediately move such vehicle in case of necessity.
- **(b)** If the vehicle is owned or operated by a fire department and is clearly marked as a fire department vehicle.

Note: No parking within 15 feet, both ways, regardless if the curb is painted or NOT.

Prohibited Stopping, Standing, or Parking

<u>22500.</u> No person shall stop, park, or leave standing any vehicle whether attended or unattended, except when necessary to avoid conflict with other traffic or in compliance with the directions of a peace officer or official traffic control device, in any of the following places:

- (a) Within an intersection
- **(b)** Within 15 feet of the driveway entrance to any fire station
- (c) In front of a public or private driveway
- (d) On any portion of a sidewalk
- (e) On the roadway side of any vehicle stopped, parked
- (f) Upon a bridge
- **(g)** In front of or upon that portion of a curb that has been cut down, lowered, or constructed to provide wheelchair accessibility to the sidewalk.

22521. No person shall park a vehicle upon any railroad track or within 7 ½ feet of the nearest railroad

Vehicle Repairs

7.76.010 - Purpose.

The Board of Supervisors finds and declares:

- 1. The repair of vehicles on highways other than emergency repairs constitutes an unsightly and hazardous condition.
- 2. The public health, safety, and welfare would be benefitted by prohibiting vehicle repair on highways other than emergency repairs.

7.76.020 - Definitions.

As used in this chapter the following definitions apply: (a)"Emergency Repairs" means either any repair which is accomplished within one hour or any repair as may be necessary in case of an accident or mechanical failure to enable the removal of the vehicle from the highway. In the case of any accident or mechanical failure, the emergency repair shall be completed within twenty-four hours of the accident or mechanical failure.

Commercial Vehicles

7.28.030 - Parking of commercial vehicles.

No person, firm or corporation, nor any agent or employee thereof, shall stop, leave standing, or park for the period of more than one (1) hour any commercial vehicle, whether attended or unattended, upon a street, road, highway or other thoroughfare, or place of whatever nature, publicly maintained and open to the use of the public for the purpose of vehicular travel, located in any residential zone in the unincorporated area of said County, except when such vehicle is in actual use for the transaction of any lawful business in said zone or is temporarily disabled.

Other Uses for Vehicles

7.96.010 - Findings of fact and intent.

The San Mateo County Board of Supervisors finds that substantial public health, safety, and quality-oflife concerns are posed by persons who sleep, during evening hours, in vehicles, campers, and trailers parked on public streets, on public easements, in public parks, and in off-street parking lots located in the unincorporated area of the County. Residents of the unincorporated area of the County have informed this Board of litter and unsanitary conditions related to individuals who sleep in vehicles, campers, and trailers. Further, County residents have expressed to this Board that allowing people to sleep in vehicles, campers, and trailers in these places is incompatible with the character of communities within the unincorporated area of the County. Moreover, the presence of individuals sleeping in vehicles, campers, and trailers creates anxiety for some County residents, who contact law enforcement personnel to report suspicious vehicles. Likewise, this Board finds that persons sleeping in vehicles, campers, and trailers are at a heightened risk of being the victim of assault, robbery and other criminal activity. It is the purpose and intent of the Board of Supervisors to regulate the use of motor vehicles for sleeping in order to prevent the effects described above.

Abandoned Vehicles

Vehicles parked or left standing upon a highway for 72 or more consecutive hours is a violation of a local ordinance authorizing removal. A San Mateo County Sheriff's Office 72 hour warning notice will be attached to the vehicle warning the owner(s) of the intent for removal of an abandoned vehicle. To report:
